The *Colorado Primary Drinking Water Regulations* (5 CCR 1002-11) Backflow Prevention and Cross-Connection Control Rule have been in full effect since January 1, 2016. The state of backflow prevention across Colorado will be discussed with an emphasis on emergency response from potential backflow contamination events. The Seminar will consist of four different segments.

- The Colorado Department of Public Health and Environment will review the existing regulatory requirements with an emphasis on what was learned in 2017 and focus on upcoming program developments with regards to survey requirements at duplex service connections and additional guidance for control requirements. - Conference attendees will participate in multiple table top exercises that will present suspected backflow contamination events.
